The engagement shall be purely on work performance basis initially for a period of six months. The Hon'ble High Court may revise or extend the engagement. The selected retired judicial officers shall be required to translate judgments of Hon'ble Supreme Court and Hon'ble High Court and remuneration for this work shall be paid at the rate of Rs. 100/- per page of the judgment (not the page of translated version). This remuneration shall be paid only if the translation is done using SUVAS tool and verified as such.

Further, mere submission of application shall not confer any vested right on an applicant to get selected for the work of translation of judgments. In this regard, Hon'ble High Court reserves the right to accept or reject any or all the applications without assigning any reason. Further, the work of translation and criteria i.e. per page basis shall be supervised by the AI-Assisted Legal Translation Advisory Committee of this Hon'ble High Court and it would not be in the discretion of the officer or the person translating it.
