- Mentioning of Civil Writ Petitions and civil cases will be made before Hon'ble Mr. Justice Ajay Kumar Mittal and regarding criminal cases before Hon'ble Mr. Justice T.P.S.Mann except the cases which are listed in urgent/motion/regular hearing before any Hon'ble Bench, and re: which mentioning will be made before the same Hon'ble Bench.
- Cases upto the year 1990, cases relating to Senior Citizens, Crime against Women, differently abled persons, Juveniles, Marginalized Sections of society, Prevention of Corruption Act, cases in which proceedings before lower Courts have been stayed and remand cases from Hon'ble the Supreme Court will be taken up on priority basis.
- Ordinarily filed RSAs up to the year 2017 wherein notice is yet to be issued will be shown in urgent list.
- All previous orders in respect of earlier Roster stand superseded.
- Specially assigned matter under specific order will be listed before the same Bench.
- Specially constituted Benches to hear murder references along with Criminal Appeals shall continue.
