

Hon'ble the Acting Chief Justice has been pleased to order that during the ensuing spell of Holi Break, 2024, First Anticipatory Bail Applications, Cases relating to Life and Liberty (Protection matter of Runaway Couples) and 'any other Urgent Matter' as may be permitted by Hon'ble the Senior most Vacation Judge through Registry; will be entertained on **27.03.2024 and 28.03.2024**.

Habeas Corpus Petitions will also be entertained from **23.03.2024 to 29.03.2024**.

Request for listing the case on same day or next Court working day in case of First Anticipatory Bail Applications or Protection matters of Runaway Couples as well as taking up of 'any other Urgent Matter' including Division Bench matters, if any, will be made before Hon'ble the Senior most Vacation Judge available on the date mentioned only on Court Working days.
4. No filing except First Anticipatory Bail Applications, Protection matter of Runaway Couples, Caveat Application u/s 148-A CPC and cases in which mentioning for listing the case during Holi Break has been allowed by Hon'ble the Senior most Vacation Judge will be entertained during the Holi Break on 27.03.2024 and 28.03.2024.

However, Habeas Corpus Petitions will be entertained without mentioning during the Holi Break from 23.03.2024 to 29.03.2024.

Filing of all cases will be resumed w.e.f. 30.03.2024.

Moreover, Habeas Corpus Petitions, Bail Applications and Applications for Suspension of Sentence (*except Subsequent Bail Applications filed by the same accused and Subsequent Applications for Suspension of Sentence filed by the same accused*) adjourned for the period 23.03.2024 to 31.03.2024 will be listed for the date so adjourned or on next court working day, if the said date is a gazetted holiday.

The Adjourned Subsequent Bail Applications/ Subsequent Applications for Suspension of Sentence/ Applications for Cancellation of Bail/ Applications in Decided Cases will only be listed subject to the availability of the Hon'ble Judge who had decided the earlier Bail Application or main case.
