Request for listing the case for the same day or next Court working day in case of First Anticipatory Bail Applications and Protection matters of Runaway Couples as well as taking up of 'any other Urgent Matter' including Division Bench matters, if any, will be made before Hon'ble the Senior most Vacation Judge available on the date mentioned only on Court Working days.
