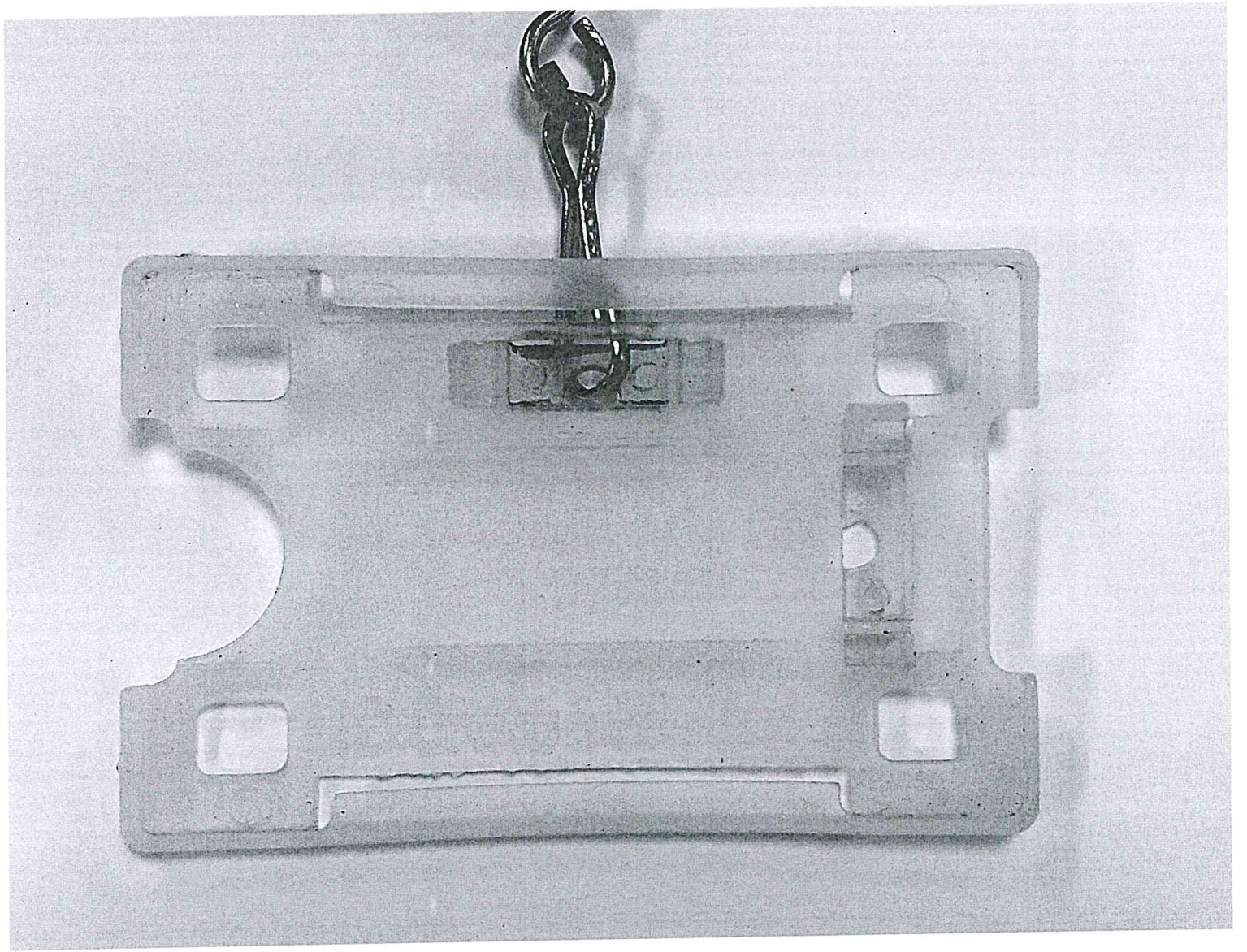
Sealed quotations are invited in the name of the Registrar General, High Court of Punjab and Haryana, from reputed and financially sound firms for the printing and supply of Identity Cards along with accessories for the official use of this Court. The quotation including minimum rates, GST, labour charges and F.O.R. be sent to the Computer Branch of this Court. The requirement includes printing and supply of 307 fresh Identity Cards, comprising 02 Identity Cards for Hon'ble Judges, 04 Identity Cards for Judicial Officers and 301 Identity Cards for officers and officials of this Court, along with accessories. The accessories required for the fresh Identity Cards are 305 brackets, 45 red lanyards, 85 black lanyards, 95 green lanyards and 80 blue lanyards.

In addition to the above, only accessories are required for the previously generated Identity Cards, which include 2611 brackets, 335 red lanyards, 526 black lanyards, 992 green lanyards and 721 blue lanyards. The sample of the above-mentioned items can be seen on any working day in the Exclusive Cell of this Court (Room No. 29, Third Floor, Old District Court Building, Sector-17), between 10.00 A.M. and 5.00 P.M and also attached herewith. While submitting the quotation, the words "Identity Cards for the High Court" must be clearly inscribed on the sealed envelope.

It is further mentioned that the preparation of Identity Cards along with accessories is a regular requirement of this Court. Accordingly, the Rate Contract shall be for a period of two (2) years and may be extended for a further period of one year on the same terms and conditions, subject to the requirement of the Court and satisfactory performance of the firm.

Sealed quotations must reach the Computer Branch of this Court within 21 days from the date of publication of this notice on the official website of the High Court. Quotations received after the due date shall not be considered. The High Court reserves the right to accept or reject any quotation, wholly or partly, without assigning any reason. The High Court also reserves the right to terminate the contract at any time by giving one month's prior notice.
