TERMS AND CONDITIONS

- 1. The Sealed Quotations, addressed to 'THE REGISTRAR GENERAL, PUNJAB AND HARYANA HIGH COURT, CAPITOL COMPLEX, SECTOR-1, CHANDIGARH' should reach in this office latest by 01.11.2025. Any offer received thereafter will not be entertained. The word "QUOTATION FOR APPLE IPADS AND SAMSUNG TABLETS" should be clearly inscribed on the top of the sealed envelope containing the quotation.
- 2.
