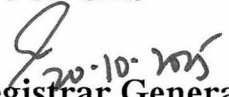

- (iii) The District and Sessions Judges concerned shall ensure that in case, any officer dealing with the cases of MPs/MLAs, such cases be immediately entrusted to some other Court of competent jurisdiction well before the next date fixed therein.
- (iv) The Fast Track Special Courts to try the offences exclusively under POCSO Act at Panchkula, Faridabad and Gurugram are established in view of the direction given by the Hon'ble Supreme Court of India in Suo Moto WP (Criminal) No. 1/2019 – Alarming rise in the number of reported Child Rape Incidents.
