- (iii) The POCSO courts at Sangrur and Tarn Taran are established as per the scheme formulated by the Government of India, Department of Justice, Ministry of Law and Justice in view of the direction given by the Hon'ble Supreme Court of India in Suo Moto WP (Criminal) No. 1/2019 – Alarming rise in the number of reported Child Rape Incidents.
